The Speaker (Hon. Khatri): Honourable Members, you may be seated. Clerk, please confirm if we have a quorum.

Honourable Members, under Standing Order 31(2);

If there is not a quorum present when the Chair is taken at the time appointed for a meeting, the County Assembly immediately after saying of the prayer, the Speaker shall order the bell to be rung for ten minutes and if no quorum is present at the expiration of 10 minutes, the Speaker may direct the bell to be rung for a further five minutes and if still no quorum present the Speaker shall adjourn the County Assembly forward to the next sitting.

Clerk, please confirm if there is a quorum? Clerk please confirm.

Honourable Members, as I said earlier under Standing Order 31 (2) I will read it again; *quorum at commencement of the County Assembly;*
