The Temporary Speaker (Hon. Abdirahman Abdikadir): You may all take your seats.

[Loud consultations]

Yes, order Honourable Members...

[Loud consultations]

Members, am being told that there are some Members who are walking in; instead of ringing the quorum bell for ten minutes am requesting that we allow them to walk in, is that fair enough? Thank you. As we are waiting for rest of the Members to come in, I am requesting that we remain seated and do not leave the chambers. Serjeant-At-Arms, please be alert that no Member is allowed to leave the chambers except authorized.

[Honourable Members walked into the Chambers]
[Loud consultations]

Yes, Honourable Members we have a quorum and I want us to start the proceedings. Yes, Clerk?

MOTION

Hon. Mumba: Thank you, Mr. Speaker. Mr. Speaker Sir, I beg to move the following Motion;

Thank you, Mr. Speaker,

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Leader who is your seconder?

Hon. Mumba: My seconder is Honourable Moraa Milka.

Hon. Ngare: Thank you Mr. Speaker, I do second the Motion.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Members, I now propose the question that the Motion by the Leader of the Majority Party on appointment of the Members to the County Assembly Business Committee be considered by this Honourable House in the same terms as moved.

[Question proposed and agreed to]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Leader of Majority Party please make your contribution to the Motion?

Hon. Mumba: Ahsante Mheshimiwa Spika, nimesimama hapa kuwaambia Waheshimiwa wenzangu hii kamati ni kamati ambayo huwa kawaida inaangazia mambo yetu ya mikakati ya ndani ya Bunge, ambayo inatakiwa ipitie pale ipigwe msasa na kuona kuwa imeletwa hapa ndani ya Bunge, zile hoja ambazo zinatakikana ziingie ndani ya Bunge na vile vile katika Kamati hii huwa tuko na Spika wetu pale, ili aweze kunukuu baadhi ya yale mambo ambayo yataweza kuingia ndani ya Bunge ni ratba ambazo zinanukuliwa kutoka kwa hata Waheshimiwa wenzetu wakiwa wana hoja pale iwe na urahisishaji wa kuweza kunukuliwa ndiposa zikiingia hapa kwenye Bunge ziwe zimeweza kukaguliwa na kuonekana umuhimu wake kuingia katika Bunge na katika wengi ambao ninawaona hapa, wengi ni kama tu wawili au watatu ambao ndio wameongezeka lakini hawa wengi ni wale waliokuwa baado wengine walikuwa wakihudumu katika kazi kama hio. Yaani sio kwa hii Kamati lakini kazi kama hio kwa hivyo wana uzoefu wa kazi hii ambayo tunaenda kuwapitisha na waendele kufanya ahsante

Mheshimiwa Spika na ninawaomba Waheshimiwa wenzangu muunge mkono ili tuendeleze kazi ya Bunge hii. Ahsante.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Milka Moraa Ngare the seconder of the Motion.

Hon. Ngare: Thank you Mr. Speaker. Once again, I want to echo the same sentiments that the Speaker is harassing me directly, that the Majority Leader has brought to this House and I agree with her, that we need to have a strong Committee of House Business. We will be transacting Businesses before they get to this House, so I would also want to congratulate the ten Members that have been appointed, those who were there before and the ones who have been added. I want to give them my congratulations and to wish them all the best as they sit in the House Business Committee to transact businesses that would be coming to this House. Our work would be to see through all the Motions that are coming, statements and also trying to assist the Chairman who is actually the Speaker of the County Assembly, to ensure that we are bringing good vibrant businesses to this House and with I congratulate you and thank you so much Mr. Speaker.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable. The two gentlemen I think I will start with Honourable Manuari Juma?

Hon. Juma Manuari: Ahsante Mheshimiwa Spika kwanza hii nichukue nafasi hii kumshukuru Mwenyezi Mungu kwa siku hii ya leo, na kuwa tulikuwa tuko mapumziko kwa mda mrefu, lakini leo Mwenyezi Mungu ametuleta salama sote tukiwa hai na afya. Mheshimiwa Spika mimi nimesimama kupinga swala hili ambalo limeletwa mbele yetu na niko sababu mwafaka. Kwa sababu nikiangalia muundo uliundwa katika hawa watu kumi bora walio wekwa kulingana na maeneo ya hii Mombasa yetu, tukiangalia Sub-County ya Likoni, hakuna hata mtu mmoja ambaye amewekwa katika muundo huu ambao umewekwa tukiangalia Mvita wapo, Changamwe wapo, Jomvu wapo, Nyali wapo, Kisauni wapo, *nominated* wapo lakini ndani ya Likoni hata mtu mmoja kuweko pale tukasema na sisi watu wa Likoni kwenye Business Committee kuna mtu wetu tukiwa na jambo letu tunaweza peana pia likawekwa ama ukarudi Likoni akaja kutuhadithia kama Ferry hazifanyi kazi na yeye amevuka tumuone hapa. Kwa hivyo Mheshimiwa Spika mimi nasema nimepinga na si kuunga mkono swala hili na mimi niombe wale walio andaa swala hili warudi tena kwenye meza, waupike upya, walilete Bungeni ili na sisi tuwe na usawa wa maeneo kuwakilishwa katika kila jambo. Ahsante Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Kambi?

Hon. Juma Kambi: Ahsante sana Mheshimiwa Spika kwa kunipa fursa hii. Mimi Mheshimiwa Spika nimesimama kuunga mkono hoja hii, lakini kwa marekebisho kwa sababu katika Waheshimiwa wa Likoni mimi ni mmoja wao na House Business ndio mahali panapongwa ratiba za Bunge na itakuwa si vyema kukosekane mwakilishi yeyote wa kutoka Likoni. Kwa hivyo tunaomba hii House Business tunaunga mkono, lakini kuwe marekebisho ndio kuwe na mwakilishi wa kutoka Likoni Sub-County. Ahsante sana Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Hamida?

Hon. Noor: Thank you, Mr. Speaker for giving me this opportunity. Mr. Speaker this afternoon I am sadden because I thought I will see my name in this list because I think I am only MCA in this House who only has two committees, so I was expecting this afternoon...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Leader, allow the Honourable Member to air out her views.

Hon. Noor: So, I thought probably this afternoon I will find my name in this list! So, I reject this Motion thank you.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you for your input as well. Yes, Honourable Mwaka?

Hon. Mwaka Bakari: Ahsante sana Mheshimiwa Spika. Nami niweze kuchangia mjadala huu ambao umeletwa hapa ndani ya Bunge; nimekubali lakini naukataa kwa upande mwingine kama mimi Mheshimiwa Mwaka ni MCA Mteule na natoka sehemu ya Likoni na nawakilisha Mombasa nzima...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Member, let me just guide you. It is either you are opposing or proposing...

Hon. Mwaka Bakari: Ndio naikubali kwa sababu ni House Business na ni jambo la Nyumba hii na ni Kamati ya kuchangia biashara ya Nyumba hii. Naikubali kwa hilo kwa marekebisho nakataa ya kwamba yale yalioandikwa hapa majina, ambayo kwamba yaweze kuchangia Sub-County zote sita nikiwa hapa kama *nominated* nasemekana niko ndani ya Mombasa nzima na ni kule ambapo natoka ni Likoni ambayo kwamba sijichangii mimi bali nachangia kuwepo kwa mmoja wapo wa Likoni aweze kuwa hapo, kwa sababu hili ni jambo la Nyumba na ni jambo la kuchangia kwa kila kiongozi. Ahsante sana Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Katana? I can see you are very anxious!

Hon. Katana: Mheshimiwa Spika ahsante kwa kunipa nafasi ambayo sijaitisha lakini nimesimama kuunga mkono na vile vile nilijuze Jumba hili ya kwamba kuwa ama kutokuwa kwa Kamati hii haina faida wala hasara yoyote. Mheshimiwa Spika, kwa sababu kikubwa ni kujadili na kuratibu maswala ambayo tutakuja kuyazungumzia na mara nyingi majumba yote ya kisheria kama hivi kuna kuwa na kamati hii kwa sababu, siku nyingine Mheshimiwa Spika nilishangaa katika Jumba hili tumeletewa hoja ambayo iko katika High Court of Kenya na Jumba hili likajadiliana maswala ambayo yako kwa High Court sasa Mheshimiwa Spika niwafariji wenzangu kutoka Likoni...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Katana, could you please explain specific the issue that you are talking about and alleging?

Hon. Katana: Sasa bado najielezea Mheshimiwa Spika, ukinikatizia nitajieleza aje Mheshimiwa?

The Temporary Speaker (Hon. Abdirahman Abdikadir): You should speak with evidence.

Hon. Katana: Ushahidi Mheshimiwa Spika ni *Hansard*; wapo Waheshimiwa hapa wamesema wamesimama wakasema na wakiwa wana kilio kikubwa ya kwamba uwakilishi wa kutoka Wadi zetu za Likoni haujawakilishwa katika Kamati hizi. Ninachotaka kukiweka wazi ni kwamba hamna faida wala hasara kuwa katika hii Kamati, kwa sababu cha msingi ni kutoa utaratibu wa hoja zitakazo ingia hapa. Kwa hivyo mimi ningependa Waheshimiwa wenza tukaweze kupitisha tu ili kwa sababu kama mchana tukifungua Bunge hili Mheshimiwa Spika hakukuwa na hoja yeyote kumaanisha sisi Waheshimiwa wenyewe hatuna hoja tunaweza kupeleka katika Kamati hii ndivyo ziingie Bunge na pia sijasikia tokea tuingie katika Jumba hili Mheshimiwa Spika, sijasikia Mheshimiwa yeyote amepeleka hoja yake kupitia kwa Kamati hii na ile Kamati ikakataa kuja. Mara nyingi tunakaa hapa na tunasomewa *procedures* za hili Jumba alafu Mheshimiwa Spika anasimama na *adjournment* tunatoka na hakuna hoja yoyote. Mimi ninachokiomba Waheshimiwa ili tukaweza kufunga na twende nyumbani, tuunge mkono hoja hii ili Kamati hii iwe tayari kwa ajili ya kufanya kazi. Ahsante Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Mwaka? Are you up on a point of order?

Hon. Mwaka Bakari: Yes.

The Temporary Speaker (Hon. Abdirahman Abdikadir): What is your point of order?

Hon. Mwaka Bakari: Yangu ni kuongezea na kutolewa makosa ya kwamba sisi tumesema tumepinga; hatukupinga tumesema iwe na marekebisho kidogo na angalau na kile kilio ambacho tuko nacho kiongezewe tu pale. Hatukusema tunapinga nataka ieleweke, nasema irekebishwe angalau kile kilio ambacho niko nacho kiweze kupatikana, kiweze kukaa hapo lakini hatupingi kwa sababu kama hivi ulivyosema Kamati ya biashara ni Kamati ambayo ni ya biashara ya hii Nyumba hakupingwi kitu hapa.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Mwaka, that was not a point of order but I have just allowed you to continue with it but next time I will ask you to sight the specific Standing Order. Yes, Honourable Frankline Makanga?

Hon. Makanga: Thank you Mr. Speaker. First, I rise to support the Motion; maybe with your permission will you allow me to change language?

The Temporary Speaker (Hon. Abdirahman Abdikadir): Please proceed.

Hon. Makanga: Ahsante Mheshimiwa Spika. Kwanza nichukue fursa hii niweze kushukuru Mungu kwa sababu tumetoka kwa kipindi cha mapumziko cha mda wa miezi miwili na hivi sasa tumerudi kufanya kazi na kati ya kazi ambazo tunafaa kufanya ni kuhakikisha kwamba sisi kama Bunge tumetunga sheria, tumepitisha Miswada na hoja ambazo zitawasaidia wananchi wa Mombasa bila kuegemea mirengo ya kisiasa wala mahali tunatoka. Hii ni kwa sababu kila tunalolifanya hapa tunalifanya kwa niaba ya jamii yetu ya Mombasa na Mheshimiwa

Spika mimi labda niweze kuutoa ufahamu si kwa sababu mimi ni kati ya ambao wamechaguliwa kuwa katika Kamati hii, lakini kwa mara ya tano sasa kwa sababu *this is our fifth session of the third Assembly*, ni kwamba nimeweza kuhudumu katika Kamati hii ya kuendesha biashara za Bunge hili na hii inaongozwa na *Standing Order* zetu, ambazo Mheshimiwa Spika inasema ya kwamba, *'there shall be a Select Committee to designated by the County Assembly Business Committee consisting of...'*, ambayo inapeana uanachama wa hii Kamati. Haijasema kwamba inaangalia kimaeneo ama kikabila, ama kidini lakini muhimu inasema kwamba kutakuwako na wanachama ambapo wa kwanza ni Mheshimiwa Spika, pili ni Kiongozi wa Wengi, tatu ni Kiongozi wa Wachache alafu (d) Mheshimiwa Spika inasema, *not less than five and not more than seven Members who shall be nominated by the County Assembly Parties and be approved by the County Assembly at the commencement of every session.*

Mheshimiwa Spika kwa kipindi ambacho nimehudumu katika hii Kamati tumekuwa tuingang'ana kwa muda kwamba biashara ama hoja *and Mr. Speaker you can go back to the Hansard records* kuna Waheshimiwa hapa tangu Bunge lianze hakuna hoja ama hata kuuliza swali wameuliza. Kwa hivyo Mheshimiwa Spika ni kwamba Kamati hii tumekuwa tunakaa tuingoja Waheshimiwa walete biashara na mimi nasema hapa ili iingie katika kumbukumbu zetu ya kwamba hakuna biashara ya mtu yeyote akiwemo wa wachache ama wa wengi kutoka kwa Sub-County yeyote ambaye amekuja na hoja yake ikakataliwa. Kwa sababu majukumu ya Kamati hii ni kuweza kuangalia biashara zetu ambazo zinafaa kuja kwa Bunge then zina *meet the ratio* za kisheria, na kama ina *meet the threshold* Mheshimiwa Spika huwa zinakuja na saa zengine kwa ukosefu wa biashara, saa zengine tunafunga hata macho ili biashara ziingie na baadae zikifika hapa. Waheshimiwa walioko katika Jumba hili kwa hekima yao wameziregesha tena kwa Kamati, kwa hivyo mimi niombe Waheshimiwa hakuna yeyote ambaye anayezuliwa kuleta hoja yake na hakuna Mwanakamati mimi nikiwa mmoja wao ambae nitasema hoja hii imeletwa na mtu wa Jomvu na kwa sababu hakuna mtu wa Jomvu tutaipinga ama hoja hii imeletwa na mtu wa Mwakirunge na kwa sababu Mwakirunge wanapelekwa kule na upande ule ni wa kufanyiwa tabia mbaya sasa Mheshimiwa Spika niseme hiyo tunapinga. Kwa hivyo mimi kile nasema Mheshimiwa Spika ni kuwa Kamati hii ipite tuletewe biashara kwa Kamati tuweze kuipitisha tuweze kusongesha Mombasa mbele. Kwa hayo mengi nasimama naunga mkono, ahsante Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Frankline, thank you for your contribution. Yes, Honourable Fatma Swaleh.

Hon. Fatma Swaleh: Ahsante sana Mheshimiwa Spika kwa kuweza kunipa fursa hii. Kwanza namshukuru Mungu muumba wa ardhi pasi na kizuizi siku ya leo tumeweza kurudi sote tukiwa salama bukheir wa afya. Mheshimiwa Spika kabla sijaendelea kuhusu hii hoja Mheshimiwa mwenza amesema Mwakirunge watu wanafanya tabia mbaya; hili ni Bunge la heshima. Hiyo tabia mbaya ambayo imefanywa katika Wadi ya mwenzake japo kuwa yuko hapa aweze kusema ni tabia mbaya ipi; sisi sote Mheshimiwa ni watu wazima na awe na ushahidi Mheshimiwa Spika kwa sababu sisi sote ni Waheshimiwa hapa kama kuna tabia mbaya imeweza kufanyika Mwakirunge na yeye ana uhakika na ushahidi. Sisi kama Waheshimiwa ambao tuko hapa ndani asitulete sintofahamu na balaa kwanza Mheshimiwa Spika kabla sijaendelea na hoja atoe ushahidi na hiyo tabia mbaya aiseme.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Fatma, you are not the one to compel Members to give evidence it is only the Speaker so, you are allowed to proceed with the Motion.

Hon. Fatma Swaleh: Mheshimiwa Spika kabla sijaendelea nina haki ya kuzungumza, nimechaguliwa na wananchi ikiwa kuna Wadi inafanywa tabia mbaya nami niko hapa nimenyamaza aseme ni Wadi gani amesema ni Mwakirunge atuambie kumefanyika nini sitaendelea mimi mpaka nijue Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Fatma, you are out of order! Okay. Let me correct you; what you ought to have said is that you are requesting the Member to substantiate so I will allow that and ask the Honourable Member to substantiate.

Hon. Makanga: Mheshimiwa Mwenyekiti mimi naketi katika Kamati ya Mazingira katika Bunge hili na kama kuna Wadi ambayo taka zote za Mombasa hupelekwa; ni Mwakirunge hiyo ndio mimi nimemaanisha kwamba uchafu hubebwa Mombasa ukamwagwa Mwakirunge. Kwa hivyo katika uchafuzi wa mazingira hiyo ni kama kufanya tabia mbaya kwa sababu kunafaa kuwa na *designated places* na kama yeye kuna tabia nyengine ambayo anajua yeye aseme lakini mimi nilimaanisha taka ambazo zinamwagwa Mwakirunge. Ahsante Mheshimiwa Mwenyekiti.

The Temporary Speaker (Hon. Abdirahman Abdikadir): I think that is satisfactory? Honourable Fatma, please Honourable Fatma. Please contribute to the Motion, let us avoid the side shows.

Hon. Fatma Swaleh: Mheshimiwa Spika kwa heshima na taadhima sisi sote ni watu wazima hapa hakuna mtu hajui kama taka zamwagwa Mwakirunge kwa hivyo ukija hapa kama Mheshimiwa jieleze ueleweke si kufanya mambo ya fil finyange sisi hapa sote tumechaguliwa...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Fatma yes, I have heard you now please contribute to the Motion. Let us avoid the side shows. If you do not have any contribution...

[Interruption]

Hon. Fatma Swaleh: Mheshimiwa Spika usinihujumu sio mambo ya *side shows*, mimi sitokubali kama Mheshimiwa niliyechaguliwa Kadzandani Mheshimiwa aweze kusimama aseme kuwa kuna Wadi yafanywa tabia mbaya.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Fatma please contribute to the Motion?

Hon. Fatma Swaleh: Mheshimiwa Spika umenihujumu lakini wacha niendele. Mheshimiwa Spika, kama ulivyosikia waheshimiwa wenza kuanzia Mheshimiwa Hamida ambae ni jirani yangu pale Nyali, Mheshimiwa Mwaka mimi naomba vilio vyao hakuna mtu hajui taka zamwagwa Mwakirunge Mheshimiwa Spika. Kwa hivyo ukisimama kama Mheshimiwa Hamida ambae ni Jirani yangu pale Nyali, Mimi naomba vilio vyao viweze kusikika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): So, are you opposing or proposing?

Hon. Fatma Swaleh: Naunga mkono hoja hii lakini na mabadiliko.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you. Is there any other Member who wishes to contribute to this Motion?

[Silence]

Honourable Maryam Baimu, any contribution?

[Silence]

None. Yes, the Leader of Majority please respond to the concerns of the Members who are opposing this Motion and before you contribute, I have had a Member saying that nominated Members were not included in this list. They are here; I want to confirm they are here. We have two confirm they are here. We have two nominated Members', three nominated Members. Three, okay. Proceed please.

Hon. Mumba: Ahsante Mheshimiwa Spika nimesimama hapa kwa wale wote waliounga, waliounga na kutaka marekebisho ninashukuru kwa hisia tofauti tofauti maanake tumetoka kwa *Sub County* zote sita ambazo ni zetu za Mombasa Kaunti lakini nataka Waheshimiwa kuwaambia ikiwa kutakuwa na mabadiliko sitasema ni mabaya yatakuwa lakini nataka kutoa hofu, wasiwasi kuwa muone kuwa katika hii Kamati kwa vile hakuna jina la mtu kutoka eneo la Likoni ati kuwa hoja za Likoni hazitanukuliwa, hoja zitanukuliwa na zitasikizwa na kila Memba katika house business huwa kabla hatuja kaa huwa kuna time ya kiongozi yoyote kuleta hoja yake kule kwa Karani wa Bunge na yeye huwa ndio analeta ile hoja katika House Business kwa hivyo hoja yako lazima itasikizwa pale. Lakini ikiwa kutakuwa kunasemekana kuwa ni lazima kutafutwe memba mmoja aongezwe wakati pia tuna *execute* Mambo ya hizi Kamiti Mheshimiwa Spika ni nataka watoe hoja kuwa tutaweka nafasi hizo ambazo munataka pia ziongezeke. Kwa hivyo Mheshimiwa Spika nataka kuwatoa hofu ya kuwa wasiwe na wasiwasi tutaziweka kwa wakati manake kila mahali hakuwekwi jambo lolote likawa ati ni *permanent* lakini kwa saa hizi wacheni tupitishhe hii hoja ili tuweze kufanya kazi maanake kando na hii bado kuna Kamati nyingi ambazo ninajua zina matatizo na tunahitaji pia kuziangalia. Kwa hivyo hii naomba Mheshimiwa Spika kwa unyenyekevu Waheshimiwa wenzangu ipitisheni ili tuweze kuanza kazi hii. Ahsante.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Members. I now put the question that the Motion by the Leader of Majority Party on Appointment of Members to the County Assembly Business Committee be adopted by this Honourable House in the same terms as moved?

Yes, again Leader of Majority Party. Please move the Motion.

Hon. Mumba: Thank you, Mr. Speaker. Mr. Speaker Sir, I beg to move the following Motion.

THAT pursuant to Standing Order 30(1) of the County Assembly of Mombasa, this Assembly now stands now adjourned until Tuesday 24th February, 2026.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Pardon. Secunder.

Hon. Mumba: Secunder Mheshimiwa Bomoa.

Temporary Speaker (Hon. Abdirahman Abdikadir): Go on record Honourable Bomoa.

Hon. Omondi: I second.

The Temporary Speaker (Hon. Abdirahman Abdikadir): It's okay. Honourable Members, I now propose the question that the Motion by the Leader of Majority Party on adjournment of County Assembly be considered by this Honourable House in the same terms as moved?

[Question proposed and agreed to]

Yes, the Leader of Majority Party. Thank you.

Hon. Mumba: Ahsante Mheshimiwa Spika najua tumetoka kwa likizo lakini tumepatikana na dharura kama viongozi kwa pamoja wa Bunge la Kaunti Kenya nzima. Tunatakikana kwenda kwa mkutano maalum maarufu unaitwa *County Assembly Forum* na ambayo ni CAF na pale ndio hua tuna mambo yetu kuzungumza kwa pamoja kama Kenya nzima ambapo mkutano huo unaanza nafikiri ni kesho na ni wajibu viongozi sote, tuweze kuonekana tuwakilishe Kaunti yetu na tutoe tetesi zetu kama Bunge la Mombasa, tuweze kuzungumza na kujadiliana na wenzetu na tupate yale manufaa ambayo wale wenzetu na sisi tutoe hoja zetu tuweze kupata kusaidika. Kwa hivyo Mheshimiwa Spika hatuna budi watu ni lazima waondoke leo usiku Nairobi, hivyo basi Waheshimiwa watakuwa wamesafiri na kuhudhuria hilo kongamano ambalo ni la siku tano ndio waweze kujumuika na Kenya nzima kwa jumla. Ahsante Mheshimiwa Spika.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Bomoa.

Hon. Omondi: Honourable Speaker, it is true the way the Leader of Majority has put it, it is clear in our mind that we are supposed to attend this forum with our colleagues but even not that we need we all understand that as per now Mr. Speaker the House is still on renovation. You can see there is a lot of noise around, Mr. Speaker and even the environment is not still yet conducive for the Members to actually carry out the business. So, Mr. Speaker, I think it is good that we adjourn and as we come back I'm sure that the noise around will not be the level that it is now. I support.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Leila.

Hon. Nyache: Ahsante Mheshimiwa Spika nami kuweza kuniona, nimesimama kuunga hoja hii mkono iliokuja na kiongozi wa wengi ambae ni Mheshimiwa Prischillah Mumba kwa kweli sisi kama viongozi na sisi pia hua tuna changamoto zetu na inatokea wakati tunatajikana twende tuwasilishe changamoto zetu mahali ambako zinaweza kusikizwa. Kwa hivyo mkutano huu Mheshimiwa Spika ni wa maana sana kwa viongozi kama sisi kwa sababu na sisi tunatajikana tukae tuzungumze tuweze kufuata mwelekeo gani kama MCAs na pia chembilecho mwenzangu vile ametoka hapa amesema huko nje kuna kelele nyingi zinaendelea ni kweli Mheshimiwa Spika huko nje si kuzuri vile lakini inatajikana tukitoka safari pia turudi tuje tushirikiane na wananchi waweze kutuona karibu hata kama hatuna lakini watuone. Ahsante sana Mheshimiwa Spika nimesimama kuunga mkono.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Mwaka Bakari.

Hon. Mwaka Bakari: Ahsante sana Mheshimiwa Spika. Mimi leo niko na furaha ukaniona hivi ndio mara kwa mara nataka niongee nina furaha sana na furaha hii imeletwa kwa siku nyingi hatuko pamoja tangu Disemba mpaka hii leo tumekutana tena yote ni uwezo wa Mwenyezi Mungu kwa hivyo imeniletea furaha sana. Hoja hii iliyoletwa na Mheshimiwa Prischillah Mumba nimeionga mkono kwa sababu tunaenda kwa CAF na CAF ni chama cha ma MCAs wote Kenya nzima kujumuika ili kupeleka kilio chetu katika kile chama chetu cha CAF kwa hivyo mimi nauunga mkono kwenda na kuhudhuria kule ili tusikie changamoto ambazo ziko kila kaunti lakini tutakapofika pale na sisi kama tuna zetu na sisi tutaweza kuziweka pale ili tuweze kujumuika na wenzetu pamoja na kushirikiana ili tupeleke Kenya yetu mbele. Ahsante sana Mheshimiwa Spika na mimi nataka sote ni tuweze kujumuika kule ili tuonyeshe nguvu zetu za Mombasa Kaunti. Ahsante.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Milka Ngare you look very smart today...

[Applause]

And I hope that is not harassment.

Hon. Ngare: Thank you.

[Laughter]

The Temporary Speaker (Hon. Abdirahman Abdikadir): It is a compliment from the Honourable Speaker.

Hon. Ngare: Thank you for the compliment. I take it positively.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you.

Hon. Ngare: And coming from the Honourable Speaker of the House Assembly and do I say.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you. Proceed please.

Hon. Ngare: Thank you. I want to support the motion that has been brought to the House by the Majority Leader. I think it is important for us as MCAs of Mombasa County Assembly be together with the other MCAs from the whole country because then we are going to deliberate on things like policies and advancement of devolution that has been there for this is now almost the 10th year, it is also good that we go compare notes with the other County Assemblies and I saw on the letter that there would be an address from the President of this Republic, His Excellency Dr. William Samoei Ruto. I would really love to shake his hand. So, thank you Majority Leader for bringing this motion and I fully support it. Thank you, Mr. Speaker for giving me the chance and for the compliment.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you and I am sure the President will be privileged to also shake your hand. Yes, Honourable Frankline Makanga. For the avoidance of doubt by the way all the ladies are looking very smart. It is not only to Honourable Milka Ngare...

[Applause]

All the ladies are looking smart today. Yes, Honourable Frankline Makanga, the young gentleman please proceed?

Hon. Makanga: Ahsante Mheshimiwa Spika mimi nasimama kuunga mkono hoja hii iliyoletwa na Kiongozi wa wengi ambae amevalia rangi za UDA kwa sababu saa hii kuna ndoa ya UDA na ODM. Mheshimiwa Spika nasimama kuunga mkono kusema kwamba ni muhimu sana kama Bunge hili litaweza kuahirisha vikao vyake hadi wiki ijayo ili tuweze kuwa na nafasi ya kwanza, mambo matatu yanafanyika wiki hii, ya kwanza tuko na mkutano KICC wa CAF Mheshimiwa Spika ambapo sisi sote tunafaa kuwa hapo. Mkutano wa pili Mheshimiwa Spika wanachama wa ODM pia wana mikutano miwili, wa kwanza ukiwa wa kiongozi Daktari Oburu Odinga kulinda ground pale Siaya mahali ambapo niliishi pale miaka kama kumi iliyopita na ni mahali pazuri nimeona itafanyika mahali panaitwa Hindi Gardens mahali ambapo Mheshimiwa Spika kwa ajili ya kumbukumbu ni mahali ambapo nilipata mpenzi wangu wa kwanza nilipokuwa nimebalehe miaka hio ya hapo nyuma. Mheshimiwa Spika vile vile kwa wale wa linda wananchi watakua pia Kakamega wakiendeleza kuimarisha chama cha chungwa Mheshimiwa Spika; kwa hivyo mambo haya matatu yanatupa nafasi ya kutoka kwenda Nairobi, Siaya na hatimae kumalizia Kakamega kuhakikisha chama tawala ambacho kwa sasa kinaongoza kupitia kwa mlango wa nyuma cha ODM tunaendeleza kutengeza mambo ili Inshallah 2027 tuwe ndani ya Serikali. Kwa hayo ahsante Mheshimiwa Spika pia mimi nauunga mkono.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you, Honourable Frankline Makanga. I am glad that you have also recognized CAF as the bonafide body and not the AMCA outfit that you are championing for...

[Applause]

Honourable Frankline Makanga, thank you for the updates on ODM. I want to remind you that you are an independent candidate...

[Laughter]

But nonetheless that update is well appreciated. Yes, Honourable Fatma Swale Mote.

Hon. Fatma Swaleh: Ahsante Mheshimiwa Spika. Mheshimiwa Spika samahani umenikumbusha zile elfu kumi kumi ambazo zilitolewa na ambazo hazikujulinana zilienda wapi Mheshimiwa Spika. Mheshimiwa Spika kama unavyojua CAF ndio inaendeleza mambo ya Bunge...

[Applause]

Hio AMKA ama AMKENI Mheshimiwa Spika sijui ilikuwa inatoka wapi? Mheshimiwa Spika, mimi kama mmoja wa CAF ni jambo zuri sana na itakua vyema sana waheshimiwa wote kuwa hapo ili muone CAF ilikua inafanya kazi gani kutetea wenzetu ambao ni sisi sote ambao twapata shida si AMKA wala AMKENI. Ahsante.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Milka Ngare, are you up on a point of order?

Hon. Ngare: Yes, information...

The Temporary Speaker (Hon. Abdirahman Abdikadir): Just because I have complimented does not give you the leeway to be standing all the time.

Hon. Ngare: I want to seek some information...

The Temporary Speaker (Hon. Abdirahman Abdikadir): Please proceed.

Hon. Ngare: You wait and listen. Mr. Speaker, I do not know the ranking Honourable Members seated to my left talking about Kshs. 10,000 that was given; we would like to understand what Kshs.10,000 she is actually talking about? Two, we are going to Nairobi because it is our right to attend meetings not because CAF has done anything meaningful because we are here miserable suffering because of the same CAF that received Kshs.5 Million every year and squanders the money and there is nothing to show for it. We are actually going because we want per diem. Thank you.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Okay. I think this conversation is taking a very strange turn. Yes, Honourable Allen Katana.

Hon. Katana: Mheshimiwa Spika labda Jumba hili Mheshimiwa Spika ulilete kwa *order* kwa sababu Mheshimiwa Spika nafikiri itakua vizuri kwa hekima yako Nyumba hii uipe muongozo wa kisawa kwa sababu tusingahau *Members*...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Order! Order! Order Honourable Fatma Mote!

Hon. Katana: Tusingahau Waheshimiwa ya kwamba Standing Orders zetu zinasema kila tunachokisema tuwe tunaweza kukihakikisha na Mheshimiwa Spika kwa vigezo ambavyo vinaendelea kutajwa hapa huenda hata vikaharibu safari ambayo inatufanya tuvunje Bunge. Tukisema CAF inapewa Kshs.5 Million kila mwaka Mheshimiwa nataka kusema nimekaa katika Bunge la Mombasa kwa miaka takriban minne hakuna hata shilingi ambayo Kaunti ya Mombasa ilipeana kwa CAF Mheshimiwa Spika na kwa sababu ya kigezo hicho ziko Kaunti nyingi ambazo zimeorodheshwa zisiweze kwenda katika kongamano hilo lakini kwa kua mimi ni mmoja wa wawakishi wanaokaa katika the Governing Council ya CAF Mheshimiwa Spika nimesukuma ili Jumba hili liweze kwenda lakini...

[Applause]

Jumba hili limekua halilipi *subscription fee* ya Kshs.5 Million. Kwa hivyo Mheshimiwa Spika mimi ningeomba utoe mwelekeo kwa Nyumba hii isimame katika ajenda maana AMKA ilitajwa na ni kweli Mheshimiwa Fatma Mote aliyosema *Members* walitoa pesa zao kwa AMKA na hawajapata ripoti ya jinsi pesa ilivyotumika. Kwa hivyo Mheshimiwa Spika let the *sleeping dogs* lie tusiamshe yaliyo tulia sisi twende kwa mujibu na ratiba za Bunge tuweze kuvunja *session* hii ili Mheshimiwa Spika...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): As you finish, as you wind up, I think Honourable Milka Ngare in her feet with a point of order.

Hon. Ngare: Yes, a point of order...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Is it on the Standing Order? Or should I give you the leeway?

Hon. Ngare: Just give me the leeway Mr. Speaker as you always do.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Please do.

Hon. Ngare: Thank you. I do not think that my neighbour and good friend Honourable Allen Katana has the right and audacity to lie to this House that he has pushed for us to get to Nairobi, he has not because we got the letters from other quarters and we already have it and it has already been signed and it has gone ahead; but if you did later after we had acquired the letter Honourable Allen Katana well and good but we already got the letter it has been signed and we are going to Nairobi to listen to our President and also other things. Thank you, Mr. Speaker.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Thank you. Let that matter rest completely. I have two facts indeed we paid some money to AMKA that is a fact...

[Applause]

And I was also present when Honourable Allen Katana made the call to push that we get the official invitation. Yes, the Leader of Majority please respond.

The Leader of Majority Party (Hon. Mumba): Ahsante Mheshimiwa Spika nashukuru waheshimiwa wote kuunga mkono kujadiliana...

[Interruption]

The Temporary Speaker (Hon. Abdirahman Abdikadir): Honourable Milka Ngare, I might be forced to withdraw my compliment at this juncture please be in order.

The Leader of Majority Party (Hon. Mumba): Wamejadiliana kikamilifu na kuona umuhimu wa kwenda kuhudhuria kongamano hilo na ni vyema tuweze pia sisi kujadiliana na wenzetu na kujua ni nini haswa tunahitajika kufanya katika Kaunti zetu za Mombasa na vile vile kama Raisi wa nchi atakua pale ni wakati pia muafaka wa kuweza kujua atahutubia na kutueleza mambo ambayo yataweza kutusaidia katika Kaunti zetu; kwa hivyo ninashukuru Waheshimiwa wenza na kuunga mkono jambo hili na tuwe pamoja. Ahsanteni.

The Temporary Speaker (Hon. Abdirahman Abdikadir): Yes, Honourable Members. I now having had your debate I now put the question that the Motion by the Leader of Majority Party on adjournment of County Assembly to be adapted by this Honourable House in the same terms as moved?

[Question put and agreed to]

The Motion by the Leader of the Majority Party on adjournment of the County Assembly is adapted by this House. Yes, Clerk?
