

MOMBASA COUNTY ASSEMBLY**HANSARD REPORT**Tuesday, 8th March, 2016

The House met at 2.33pm

*(Hon. Temporary Speaker (Mr. Patrick Siminyu) in the Chair)***PRAYERS**

Hon. Opeya: I propose that this session 29th sitting 8th March, Tuesday 2016 Hon. Siminyu to be the Temporary Speaker for this session.

Hon. Amur: Mr. Speaker I second Hon. Opeya that Hon. Siminyu be the Speaker for today.

*(Consultations)**(Question proposed)*

Hon. Temporary Speaker (Mr. Siminyu): Hon. Members it has been proposed by Hon. Opeya and seconded by Hon. Amur that Hon. Patrick Siminyu to be the Chair of this session and open it up to Members, so I put it to question.

*(Question put and agreed to)**(Applause)*

Hon. Nzai.

Hon. Nzai: Ahsante sana Mheshimiwa Spika. Kwanza nataka kuchukua fursa hii kumpongeza Gavana wetu kwa kazi nzuri ambayo amefanya Bwana Spika; na baada ya kuwa nje huko Malindi kama unavyojua Bwana Spika chama chetu cha ODM kiliweza kuibuka na ushindi mkubwa.

Hivyo basi tunataka kuchukua fursa hii kumpongeza kwa kazi yake nzuri na kwamba chama kimezidi kupewa nguvu.

Hongera ziende kwake kwa kazi safi na wote waliotumikia hata Mheshimiwa Raila kuja kwake na wale wengine wote ambao wameweza kujitoa kwa hali na mali kuona kwamba tumeweza kukipata tena kiti cha ODM. Ahsante, Bwana Spika.

Hon. Temporary Speaker (Mr. Siminyu): Yes Hon. Duncan Onyango.

Hon. Onyango: Ahsante Bwana Spika, mimi namuunga mkono jirani yangu hapa; nafikiri sote tumeziona kwa runinga na hiyo ni thibitisho wazi kwamba hata katika uchaguzi ujao bado hatutakuwa na mtu wa kupingana nae.

Yangu ni kupongeza sana viongozi wetu wa ODM kwa kazi ambayo imefanyika kule Malindi. Ahsanteni.

Hon. Temporary Speaker (Mr. Siminyu): Yes Hon. Amur.

Hon. Amur: Ahsante Bwana Spika, nami nawaunga wenzangu kusema kwamba Mombasa na Pwani nzima itaimarishwa na ODM.

Hii ni dhahirisho kwamba Gavana wa Mombasa kupigana na serikali kuu ilikuwa inaonyesha kwamba ujasiri wake unafahamika katika Kenya hii.

Hii ni dhahirisho kwamba Gavana 001 anaweza hata kupigania uraisi kwa nchi hii na akaibuka ushindi, ilikuwa ni kupimana nguvu kuangalia 2017 uwezo wetu na imedhahirika wazi kwamba Gavana Joho anaweza kupewa uraisi katika nchi hii.

Kwa sasa Mombasa itaendelea kuwa ODM *zone* na hata akija Raisi na serikali kuu nzima Mombasa Pwani sisi tuna imani kuwa Gavana Joho ameshikilia kiti kikamilifu na hiyo ndio imeleta shida kwake na vita vikubwa na serikali kuu kwa kuwa ana msimamo wake na chama chake ni dhahirisho Kenya nzima kwamba yeye sio mtu kigeugeu, ana msimamo na chama chake na amedhahirishia wakenya kwamba yeye ana uwezo kushika hata makamo wa Raisi.

Ni kudhahirisha kwamba Mheshimiwa Joho ana tajriba kubwa Kenya na 2022 atakuwa Raisi wa Kenya, ahsante Bwana Spika.

Hon. Temporary Speaker (Mr. Siminyu): Yes Hon. Kizito.

Hon. Opeya: Thank you Mr. Speaker, I would like to inform my colleagues that I was in Malindi yesterday, specifically at the polling station, and if it wasn't for our Governor we could have lost.

Secondly I would like to issue a statement regarding the short rains which are about to come; how prepared are we as a County in terms of drainage? I would like it to be directed to the relevant Committee of the County executive to bring a statement here and reply to the House how prepared they are with Mombasa County.

This time round, how far they have reached. Thank you, Mr. Speaker.

Hon. Temporary Speaker (Mr. Siminyu): Yes Hon. Opeya I will give you that opportunity to bring that statement so that I can direct it to the relevant Committee, when will you bring the statement?

Hon. Opeya: Tomorrow morning.

Hon. Temporary Speaker (Mr. Siminyu): Okay, Clerk, Hon Zainab you have a statement?

Hon. (Ms.) Zainab Mumba: Thank you Mr. Speaker Sir. I wish to bring this statement which was brought by Hon. Mary Akinyi regarding a report on provisional protective gear for County environment workers.

(Hon. (Ms.) Zainab Mumba read statement)

“The above matter refers.

It is the responsibility of the employer under the Occupational Safety and Health Act Cap 217 Laws of Kenya to provide for appropriate protective gear and clothing to its employees. The attached list is the type, size of the requirements for year 2015/2016.

In the department of Water, Environment and Natural resource, we have 347 workers and the sizes are medium, large, XL, XXL, and XXX, Thank you Mr. Speaker.
