Mr. Speaker the Holland tractor was procured in 2015 for Kshs. 6.9 Million and has the following implements:

So far it has ploughed 110 acres before grounded using a casual operator. The process of recruitment of one operator has started and is before the County Public Service Board.

The funds for his remuneration have been set aside and it is expected that the process of recruitment will be finalized by end of September, 2016.

Mr. Speaker Sir, it is evident that the tractor is not in use due to lack of operator. Once the operator is recruited then the tractor will resume its operations immediate.
