The House met at 2:39p.m.

**The Deputy Speaker:** Have your seats, yes Clerk?

**Hon. Thoya:** Thank you Mr. Speaker. Mr. Speaker Sir a statement was requested by Hon. Samba...

#### STATEMENTS

Hon. Feddis Mbura?

**Hon. (Ms.) Mbura:** Thank you Mr. Chairman for giving me this opportunity. Mr. Speaker Sir I seek to know from the Chairperson Committee on Transport, Infrastructure and Public Works whether he is aware of the poor status of feeder roads in Mwakirunge Ward brought about by the heavy rains, and whether the County government has any immediate plans to remedy the situation like putting murram as a temporary measure. Thank you Mr. Speaker Sir.

**The Deputy Speaker:** Yes Committee on Transport any response?

**Hon. (Ms.) Mwaka Bakari:** Yes Mr. Speaker I am aware that this is a rainy season all over the Country so I wish to take this opportunity to discuss the matter with the Committee of Transport.

**The Deputy Speaker:** So it means you are aware?

**Hon. (Ms.) Mwaka Bakari:** Yes I am aware.

**The Deputy Speaker:** So you will respond back after sitting with your Committee?

**Hon. (Ms.) Mwaka Bakari:** Yes.

**The Deputy Speaker:** Yes Hon. Feddis Mbura?

**Hon. (Ms.) Mbura:** Sawa, ahsante sana Mheshimiwa Spika ningepomba tu kumjulisha Mwenyekiti wa Uchukuzi kwamba hali ni mbaya. ### STATEMENT

#### RESPONSE TO THE QUESTION ON THE RECENT EMPLOYMENT OF WORKERS BY THE COUNTY GOVERNMENT

Yes Chairperson Committee on labour and social welfare Hon. Renson Thoya, respond to the statement.

**Hon. Thoya:** Thank you Mr. Speaker Sir. I wish to give the following statement on the recent employment of workers by the County government, a concern raised by Hon. Tobias Samba in this House.

Mr. Speaker Sir, recruitment in the public service is based on an existing scheme of service; a scheme of service is a career entry and progression guide which provides well defined career structures and clearly defined job description and specification at all levels. The recruitment and selection process by the County Public Service Board (CPSB) involves the following:

1. Declaration of vacant posts
2. Advertising the vacant posts
3. Receiving applications (Manual and Online)
4. Capturing applicant's information
5. Verification of applicant's bio data
6. Shortlisting/pre selection
7. Selection interviews and
8. Appointment by the County Service Board.

Mr. Speaker Sir, the following interviews were conducted by Mombasa County Public Service Board as at March, 2018.

Interview for MSF conducted between 5<sup>th</sup> and 8<sup>th</sup> March, 2018 at the MCSPSB Board room. The following positions were advertised and filled competitively

1. Clinical Officer- Sexual Violence program - 1 post
2. Clinical officer- Anesthetist -1 post

3. Medical doctor -5 posts
4. Nurse midwife -11 posts
5. Medical Activity Manager -2 posts
6. Psychologist
7. Sterilization Technician -3 posts
8. Nurse Triage -3 posts

Interview for positions in the office of the Governor.

Mr. Speaker sir, the following positions were advertised and filled competitively within the officer of the Governor.

1. Assistant Director, Monitoring and Evaluation
2. Assistant Director, Counter Terrorism and Extremism
3. Assistant Director, Strategy and Development.

Interview for Medical Specialist, Health Department held on 29<sup>th</sup> January, 2018.

The following positions were advertised and filled competitively by the Board

1. Radiologist
2. Intervention Cardiologist
3. Plastic and reconstructive Surgeon
4. Orthopedic Surgeon

COCSERCA Interview held on 23<sup>rd</sup> January, 2018

After the interview only three candidates satisfied the Board to be given an opportunity for the training that was scheduled to commence in March, 2018.

Mr. Speaker sir, I have already tabled the report on recruitment and selection process in the public Service by the County government of Mombasa for further information and clarification, otherwise we have done great research and we are still have great meeting with our Board.

Our real aim as a Committee is to ensure that recruitments are centralized and streamlined at the Board, in the meantime when you call the Chief Officer or the Public Service Board to give you any happening in a given department you may understand he is not ready to say. So we are trying to ensure that all recruitments are done by the Public Service Board because it is in this House that we saw some of the Hon. Members exchanging words not very happy some of them may be exchanging close here because of the issue of recruitment, and as a Committee we are not happy and we are call on the Board and the Chief Officer Environment also to tell us what is going on there. The previous recruitment for the casuals may be we did not cancel it but if we are forced, if they do not satisfy whatever this House read we will be required to cancel that recruitment so that it follows that directive they've given us. So we are trying to call everybody on the Board, other departments that are supposed to do their jobs the Board will recruit and deploy the staff to the necessary departments and if at all they cannot do they give clear guidelines on how to do in that given department. Thank you.

**The Deputy Speaker:** Thank you Hon. Renson Thoya and you can see there was a big applause for the report thank you for that. Yes Clerk?
