ILLEGAL CONSTRUCTION OF TWO HOUSES IN KATISHA AREA, FRÈRE TOWN WARD

Yes Hon. Charles Kitula?

The Chief Whip (Hon. Kitula): Mr. Speaker I wish to know from the Chairperson, Lands, Planning and Housing whether he is aware of the alleged illegal construction of two houses at Katisha area Frère Town Ward and whether the County government has any plans to inspect these buildings so as to ascertain if the construction followed the due process. Thank you Mr. Speaker.

The Deputy Speaker (Hon. Mwalimu): Yes Chairman Lands?

RESPONSE TO STATEMENT BY CHAIRPERSON LANDS, PLANNING AND HOUSING ON THE ALLEGED ILLEGAL CONSTRUCTION OF TWO HOUSES AT KATISHA AREA, FRÈRE TOWN WARD AND ANY PLANS BY THE COUNTY GOVERNMENT TO INSPECT THESE BUILDINGS TO AS TO ASCERTAIN IF THE CONSTRUCTION FOLLOWED THE DUE PROCESS

Hon. Ahmed Salama: Bwana Spika ahsante na sisi kama Kamati nafikiri hilo swali tumelisikia na wiki ijayo *in shaa Allah* tutajaribu kutembelea mahali pale na tutaleta majibu. Mheshimiwa Spika kuna miji mingine yatisha kama Katisha lakini tutahakikisha kama Kamati tumefika na tutaleta majibu.

The Deputy Speaker (Hon. Mwalimu): So you are committing yourself to bring two responses next week.

Hon. Ahmed Salama: Next week.

The Deputy Speaker (Hon. Mwalimu): Good.

Hon. Samba: Point of Order Mr. Speaker!

The Deputy Speaker (Hon. Mwalimu): Point of order on what?

Hon. Samba: I am standing under 41(2) (c). I have a statement I need to make, if you allow I will proceed.

The Deputy Speaker (Hon. Mwalimu): That statement on what?

Hon. Samba: On demolition of structures within the County, this goes to the department of Devolution and Public Services, it is of public interest.

The Deputy Speaker (Hon. Mwalimu): Your statement will be discussed in the next House Business and we will allot you time next week, due to its urgency on Tuesday you will give the statement.

Hon. Samba: Thank you Mr. Speaker.

The Deputy Speaker (Hon. Mwalimu): What is it Hon. Mwanwiri?

Hon. Athman Mwanwiri: Niko na kauli Mheshimiwa kuhusiana na masuala ya mikopo ya Waheshimiwa na masuala ya marupurupu baada ya hatamu yetu.

The Deputy Speaker (Hon. Mwalimu): Did you notify the Speaker?

Hon. Athman Mwanwiri: Mheshimiwa Mwenyekiti ni swala la dharura kwa sababu tunapitia changamoto nyingi chini ya ibara 41(2)(c).

The Deputy Speaker (Hon. Mwalimu): Hon. Mwanwiri I understand your statement and it is for the interest of the honourable Members and staff of County Assembly but the Table Clerks will take note and next week on Thursday you will bring your statement in this Honourable House.

The Deputy Speaker (Hon. Mwalimu): Hon. Members under our Standing orders we deferred putting a question yesterday until today, so before i direct the House i will ask the mover to first reply after that i will direct what will transpire. Yes Hon. Kitula?

The Chief Whip (Hon. Kitula): Mheshimiwa Spika ahsante sana kunipatia fursa hii kuweza kutoa maoni yangu na pia kutoa shukrani kwa wale Wabunge wote waliweza kuniunga mkono wakati wa hoja ilioweza kuzungumziwa katika kikao cha jana. The Deputy Speaker (Hon. Mwalimu): Hon. Members, the question on the Motion was deferred yesterday under Standing Order 205 plus Standing Order 50(3) and the mover has responded.

I now direct that the Hon. Members to vote on this Motion and the results will conclude either ayes have it or nays have it. So Serjeant-At-Arms prepare the ballot box, it will be a secret ballot....

(Preparations for secret ballot done)

...Serjeant make sure that no Member enters or leaves the Chambers.

(The Serjeant-At-arms complied)

Okay order Hon. Members, we are about to begin the voting you will be called one at a time and we have designated that you are going to vote on my right hand side where the Serjeant is standing and the ballot box is in front of the Mace. Yes Clerk, begin.

(The Clerk of the Table called out names of Hon. Members)

Hon. Members it is either yes or no. Yes you are supporting or No you are opposing and I am reminded by the Clerk you can also abstain; it all depends on you, proceed.

(Hon. Members voted)

Order Hon. Members! The voting has concluded; the Motion on purchase of County social welfare buses for the residents by Hon. Kitula, the votes were cast as follows; one abstained, ayes got seven votes and the nays got 18 votes...
