STATEMENTS

STATUS OF PETITION ON TRADERS EVICTED AT MAMA NGINA DRIVE

Yes Hon. Murfad Amur?

Hon. Murfad Amur: Thank you Mr. Speaker Sir, I seek to know from the Chairperson Committee on Labour and Social Welfare and the Chairperson Committee on Trade, Tourism and Investments on the status of petition on traders evicted at Mama Ngina Drive, which was committed to both Committees on Wednesday, 31st July, 2019 during the 70th Sitting. DEMOLITION OF STRUCTURES IN TUDOR WARD COOL BREEZE AREA
