## **VACANCY IN THE OFFICE OF THE SPEAKER**

**NOTICE IS HEREBY GIVEN THAT** Pursuant to Section 7B of the County Governments Act, His Excellency the Governor published in the Kenya Gazette that the first sitting of the County Assembly will be held on **Friday, 23<sup>rd</sup> September, 2022 at 10.00 am.**

Pursuant to Article 178 of the Constitution of Kenya, 2010, Section 9A of the County Governments Act 2012 and Standing Order 5 of the County Assembly Standing Orders, the Office of the Speaker of the County Assembly shall become vacant upon the first sitting of the County Assembly thus election of the Speaker will be held on **Friday, 23<sup>rd</sup> September, 2022 at 10.00 am.**

Interested persons who qualify to be elected as members of County Assembly but are not such members are therefore invited to submit nomination papers for election to the Office of Speaker of the County Assembly of Mombasa. The person should not be disqualified by any law.

### **Application Criteria**

Persons interested in filling the above position should submit:

- i. Duly filled and signed nomination forms;
- ii. Clearance Certificate from the Independent Electoral and Boundaries Commission;
- iii. Clearance from the Ethics and Anti-Corruption Commission
- iv. Clearance Certificate from the Kenya Revenue Authority (KRA);
- v. Clearance Certificate from the National Police Service;
- vi. Certified copy of the National ID or passport; and
- vii. A copy of the Curriculum Vitae (C.V) and supporting documents
- viii. 2 Coloured passport photos

Nomination papers are to be collected in person by the interested applicants from the Office of the Clerk of the County Assembly at Mombasa, County Assembly Buildings, Mombasa, during working hours from Friday 16<sup>th</sup> September 2022 to Tuesday 20<sup>th</sup> September 2022. The Office of the Clerk shall also remain open on Saturday, 17<sup>th</sup> September, 2022 and Sunday 18<sup>th</sup> September, 2022 between 9.00a.m. to 5.00p.m for the purpose of collection of nomination papers.

Completed nomination papers, together with detailed curriculum vitae of the candidate and relevant supporting documents, should be **HAND DELIVERED** to the Office of the Clerk of the County Assembly at County Assembly Buildings, Mombasa not later than **Wednesday, 21<sup>st</sup> September, 2022 at 10.00 a.m.**
