Mr. Speaker Sir, I wish to give notice of the following motion:

THAT AWARE that, Section 106 the County Governments Act 2012, provides integrating National and County planning basing the County plans on the functions of the County Governments as specified in the Fourth Schedule of the Constitution and relevant National Policies;

FURTHER AWARE that the recent global economic decline following the Covid 19 pandemic, geo-political trade wars, constriction of the logistics industry and its impact on the local residents has created a threat to the global competitiveness within the County;

NOTING THAT effective coordination between MCAs and other County Government departments, and collaboration with the private sector and civil society will ensure efficient and effective service delivery and transformation of the economy;

FURTHER NOTING THAT there is lack of coordination between various actors in the development arena thus leading to duplication, waste of resources and stalling of projects;

CONCERNED THAT if ward-based development coordination framework is not established as a tool to align and coordinate various actors, key stakeholders and partners, the County will not have a common vision of shared prosperity.

I therefore urge this Assembly to **RESOLVE**;

1. **THAT**, the County Government to provide strategic coordination, leadership, solutions and development at ward level aligned to Section 106 of the County Government Act, 2012 to meet the immediate needs and providing opportunities for business growth and innovation at the ward level.

2. **THAT**, the County Government to facilitate ward level concrete action- between County Government, international organizations, civil society and private sector to achieve sustainable development.
