PREVENTIVE AND MITIGATION MEASURES AGAINST CANCER, LIFESTYLE AND OTHER MALIGNANT DISEASES

Yes, Honourable Juma Mwalimu?

Hon. Juma Mwalimu: Thank you Mr. Speaker Sir. Mr. Speaker Sir, I beg to give the following Notice of Motion:

THAT AWARE that, Article 43 of the Constitution provides for; among other matters, the right to the highest attainable standard of health which includes the right to affordable health care services;

FURTHER AWARE that lifestyle diseases such as cancer, diabetes, hypertension among other diseases have been on the rise in Mombasa County due to lack of proper preventive strategies;

NOTING THAT primary prevention and screening for chronic diseases are considered the best strategy to curtail the rise of these malignant diseases;

CONCERNED that a big percentage of the residents of Mombasa County are economically disadvantaged thus may not afford the cost of screening services;

FURTHER CONCERNED THAT, continuous absence of preventive strategies is likely to transfer economic burden of the chronic diseases to an already financially challenged population or exacerbate the prevalence of the diseases;

I, therefore urge this Assembly to RESOLVE:

1. THAT the County Government through the Department of Health to establish a regular annual programme for screening lifestyle and malignant diseases such as cancer, diabetes, hypertension in all wards at affordable fees

2. THAT, the Department of Health to establish a prevention and mitigation programme against lifestyle and malignant diseases including awareness campaigns, sensitization forums and other sustainable measures in all Wards.
