The questionnaire may then be returned together with true copies of the nominees curriculum vitae/ personal credentials/ academic certificates and other legal requirements or testimonials by **Thursday, 30th April 2026 at 4.30 pm**. The nominees should also enclose true copies of current clearance certificates from the following bodies:

- 1. Ethics and Anti- Corruption Commission (EACC)**
- 2. Directorate of Criminal Investigation (DCI)**
- 3. Kenya Revenue Authority (KRA)**
- 4. Higher Education Loans Board (HELB)**
- 5. Credit Reference Bureau (CRB)**

The originals of the aforementioned documents should be submitted to the Committee at the approval hearing.

Members of the public are invited to attend the approval hearing sessions.

Further, members of the public are also invited to submit any information or comment on the suitability or otherwise, of any of the candidates for appointment to the respective position. The submissions may be made by way of sworn statements or affidavits and may be accompanied by any documentary evidence.
